DER-BAT-2026-39**

**EUROPEAN COMMUNITIES (BIRDS AND NATURAL HABITATS) REGULATIONS, 2011
(S.I. No 477 of 2011)**

DEROGATION

Granted under Regulation 54A of the European Communities (Birds and Natural Habitats) Regulations 2011, hereinafter referred to as “the Habitats Regulations”.

The Minister for Housing, Local Government & Heritage, in exercise of the powers conferred on him by Regulation 54A of the Habitats Regulations hereby grants to **Mary Sheehan of National Parks and Wildlife Service, Killarney National Park, Kenmare Road, Muckross, Killarney, County Kerry, V93 N673** a derogation. It is stated that this derogation is issued:

- A. For the purpose of research and education, of re-populating and re-introducing these species and for the breeding operations necessary for these purposes, including artificial propagation of plants
- B. As there is no satisfactory alternative, and the action authorised by this derogation will not be detrimental to the maintenance of the population of **bats** referred to below at a favourable conservation status in their natural range.

This derogation authorises the following:

- 1. Roost disturbance
- 2. Actions authorised within the derogation

The derogation is issued in respect of the following **bat species**:

Terms and Conditions

1. This derogation is granted solely to allow the activities specified in connection with the works located at of **National Parks and Wildlife Service, Killarney National Park, Kenmare Road, Muckross, Killarney, County Kerry, V93 N673**, for **Mary Sheehan**.
2. All activities authorised by this derogation, and all equipment used in connection herewith, shall be carried out, constructed and maintained (as the case may be) so as to avoid unnecessary injury or distress to any species of **BAT**. Anything done other than in accordance with the terms of this derogation may constitute an offence
3. This derogation may be modified or revoked, for stated reasons, at any time. In addition, the Minister reserves the right to revoke the derogation where updated information indicates that the basis upon which the derogation was granted has materially changed.
4. The mitigation measures outlined in the application report (**Supporting Information for an Application for Derogation under Regulation 54 & 54A of the European Communities (Birds and Natural Habitats) Regulations 2011 to Undertake Bat Population Assessments in Killarney National Park, Co. Kerry**), together with any changes or clarification agreed in correspondence between NPWS and the agent or applicant, are to be carried out. Strict adherence must be paid to all the proposed measures in the application.
5. The actions which this derogation authorise shall be completed between **13th January – 31st December 2026, inclusive**.
6. The works will be supervised by **Mary Sheehan, with Calum Sweeney, Conor Rowlands, Michael McSweeney & Shonagh Gray under supervision**
7. If this derogation addresses works that are subject of a planning application, no such works permitted under this derogation can occur until planning permission is granted.
8. If this derogation expires prior to works permitted under this derogation commencing, a new application must be sought in advance, including the provision of any updated data or reports.
9. This derogation shall be produced for inspection on a request being made on that behalf by a member of An Garda Síochána or an authorised NPWS officer appointed under Regulation 4 of the Habitats Regulations.
10. On completion of the actions which this derogation authorises, all recordings of bat species affected will be made using the standardised data form provided below and must be submitted to the NPWS **within four weeks of the expiry date of this derogation**. Included with the below returns form, a report will also be submitted to wildlife.reports@npws.gov.ie detailing results of works and success of mitigation. **Both documents must be submitted to constitute a derogation return.**

Please outline your analysis below and state how the applicant has provided evidence to support your conclusion:

The derogation is considered under Regulation 54(2)(b) to enable NPWS staff to carry out Bat surveys, including but not limited to internal roost inspections in Killarney National Park. The derogation application form and associated supporting documentation provided by the applicant has been reviewed in full.

Conducting regular Bat population assessments and roost audits by NPWS staff enables the Department to fulfil the monitoring requirements under Article 11 of the Habitats Directive, and are necessary to underpin the Article 17 conservation status assessments and the Lesser Horseshoe Bat species action plan 2022 – 2026 (NPWS & VWT (2022)). During the winter, internal roost counts are required to conduct a comprehensive count of Lesser horseshoe bats (*Rhinolophus hipposideros*). This requires access into buildings and cave systems within the Park by staff, which may cause disturbance to the species. In the summer months, the majority of the surveys carried out in Killarney National Park are emergence surveys and therefore disturbance is very limited at this time of year.

The proposed bat surveys will enable NPWS staff to stay informed on the health of the bats in Killarney National Park and the current state and suitability of the roosts present. The monitoring of bat roosts also allows NPWS staff to understand which specific roosts and what precise linear features and other habitats the bats are using regularly or intermittently. This information will inform any potential conservation measures required to satisfy the site specific conservation objectives for the Lesser horseshoe bat, which are a Qualifying Interest for Killarney National Park.

There are 13 lesser horseshoe roosts within Killarney National Park that are surveyed in the winter and summer months during the national Lesser horseshoe roost monitoring scheme. There are also at least two buildings with Common Pipistrelle (*Pipistrellus pipistrellus*) and Soprano Pipistrelle (*Pipistrellus pygmaeus*) bats present that are surveyed every year.

The EAU is of the opinion that this application meets the criteria to satisfy reason 54(2)(d). Based on the above, the application can now proceed to Test 2 |

Alternative solutions to the proposed approach have been considered by the applicant, and the evidence has been reviewed. The alternative solutions suggested by the applicant are:

1. Alternative Scenario-*Do nothing*:

If the proposed bat surveys are not carried out, the Department’s monitoring requirements under Article 11 of the Habitats Directive necessary to underpin Article 17 conservation status assessments would not be met. Also, actions in the Lesser Horseshoe Bat Species Action Plan 2022-2026 could not be fulfilled.

If the survey work is not completed within the Park each year, NPWS will not be informed on the health, success and/or failure of roosts and populations of bats.

2. Alternative Scenario- *Only carry out emergence surveys*:

Relying on data from emergence surveys only in winter constitutes an incomprehensive roost count considering bats are in and out of states of torpor, meaning some bats will not emerge from the roost. Therefore, the Department’s monitoring requirements under Article 11 of the Habitats Directive necessary to underpin Article 17 conservation status assessments would not be fully met. Also, actions in the Lesser Horseshoe Bat Species Action Plan 2022-2026 could not be completely fulfilled.

Based on the assessment of the application documentation, it is regarded that the applicant has considered the available alternative solutions and the proposed approach is the only satisfactory alternative. The EAU has concluded that the application has passed Test 2 and can proceed to Test 3.

The applicant has outlined in detail the best practice methodology that will be followed during the proposed bat roost assessments. The staff listed in the attached application are trained and experienced bat surveyors. Any inexperienced bat surveyors will be accompanied and supervised by an experienced bat surveyor. All applicants are familiar with the Department’s Bat Mitigation Guidelines (2022) and the Department’s guidance on the Strict Protection of Annex IV species.

The surveyors will follow the NPWS roost survey protocol outlined in the application form at all times. The internal count involves one surveyor entering the roost and counting the bats in situ when they are torpid. Surveyors will wear gloves, masks and use a head torch with red light to limit disturbance. Importantly, the count is carried out as quickly as possible and if there is any movement by the bats during the count, the count is stopped and the surveyor will leave the roost immediately.

The most recent population estimate for the Lesser horseshoe bat (*Rhinolophus hipposideros*) is over 14,000 individuals, showing an increasing trend (Roche, 2024)¹. The Common Pipistrelle (*Pipistrellus pipistrellus*) and Soprano Pipistrelle (*Pipistrellus pygmaeus*) populations have also shown an increasing trend since the car-based bat monitoring scheme has been running in Ireland, from 2003 to present (Roche & Langton, 2024²).

The EAU is of the opinion the proposed derogation would not be detrimental to the maintenance of the population of Lesser horseshoe bat, Common Pipistrelle and Soprano Pipistrelle species at a favourable conservation status in their natural range

If the answer above is Yes then the derogation may be granted, providing Tests 1 and 2 have also been met.
