**EUROPEAN COMMUNITIES (BIRDS AND NATURAL HABITATS) REGULATIONS,
2011 (S.I. No 477 of 2011)**

DEROGATION

Granted under Regulation 54 of the European Communities (Birds and Natural Habitats) Regulations 2011, hereinafter referred to as “the Habitats Regulations”.

The Minister for Housing, Local Government and Heritage (hereinafter referred to as “the Minister”), in exercise of the powers conferred on him by Regulation 54 of the Habitats Regulations hereby grants a derogation to **Ciara Hamilton of ESB, One Dublin Airport Central, Dublin Airport, Cloghran, County Dublin, K67 XF72**

The Minister is satisfied that there is no satisfactory alternative and that the action authorised by this derogation will not be detrimental to the maintenance of the population of WHALE, DOLPHIN, TURTLE OR PORPOISE referred to below at a favourable conservation status in their natural range. The Minister grants this derogation as it is:

- in the interests of public health and public safety, or for other imperative reasons of overriding public interest, including those of a social or economic nature and beneficial consequences of primary importance for the environment.

This derogation is granted in respect of Annex IV marine species only.

Terms and Conditions

1. This derogation is granted solely to allow the activities specified in connection with **geophysical and geotechnical surveys** located at **Shannon Estuary, County Clare**
2. This derogation may be modified or revoked, for stated reasons, at any time.
3. The mitigation measures outlined in the application report (**Moneypoint Hub_Risk Assessment for Annex IV Species**) together with any changes or clarification agreed in correspondence between NPWS and the agent or applicant, are to be carried out. Strict adherence must be paid to all the proposed measures in the application.
4. The actions which this derogation authorise shall be completed between the **29th January – 30th April 2025**.
5. If this derogation addresses works that are subject of a planning application, no such works permitted under this derogation can occur until planning permission is granted.
6. If this derogation expires prior to works permitted under this derogation commencing, a new application must be sought in advance, including the provision of any updated data or reports.
7. The applicant and those acting on their behalf during surveys must ensure that they adhere to the [Guidance to Manage the Risk to Marine Mammals from Man-made Sound Sources in Irish Waters](#) published in 2014 (or any updates as may be relevant in due course).
8. A qualified and experienced Marine Mammal Observer (MMO) will be appointed to monitor for marine mammals to act in accordance with the provisions of Section 2.9 of supporting document to the Regulation 54 application.
9. Visual (MMO) observations will be conducted for a pre-soft-start search of 30 minutes i.e. prior to the commencement of marine operations (MBES, SSS, sub-bottom profiling).
10. Passive acoustic monitoring may be used to supplement visual observation but it cannot be the primary method used to validate the exclusion zone.
11. The exclusion zone will be monitored and validated as being clear of marine mammals as per DAHG guidance.
12. Soft-start procedures will be applied as appropriate.
13. If Line changes are required that exceed 40 minutes the output will be reduced to below 170 dB re 1 μ Pa @ 1 m or if stopped completely then a full restart procedure will be required.
14. If there is a break in sound output from survey equipment for a period greater than 10 minutes, then all pre-start monitoring measures and ramp-up procedures will recommence prior to re-starting.
15. For drilling - If there is a break in drilling sound output for a period greater than 30 minutes (e.g., due to equipment failure, shut-down or location change) then all Pre-Start Monitoring must be undertaken in accordance with the conditions outlined in Guidance to Manage the Risk to Marine Mammals from Man-made Sound Sources in Irish Waters 2014 prior to the recommencement of drilling activity.
16. Where suitable to achieve the data collection targets it is preferable to use frequencies that are higher than the acoustic range of the likely marine mammals within the acquisition area.
17. On completion of the activities which this derogation authorises, all recordings of **whales, dolphins, turtles or porpoises** affected will be made using the standardised data form

provided below and must be submitted to the NPWS to the following email address: wildlife.reports@npws.gov.ie **within four weeks of the expiry date** of this derogation.

18. A separate narrative report must be submitted to wildlife.reports@npws.gov.ie describing the activities carried out in pursuance of this derogation. **Both documents must be submitted to constitute a derogation return.**
19. This derogation shall be produced for inspection on a request being made on that behalf by a member of An Garda Síochána or an authorised NPWS officer appointed under Regulation 4 of the Habitats Regulations.
