

Derogation Number DER-BAT-2025-287 (amended)

EUROPEAN COMMUNITIES (BIRDS AND NATURAL HABITATS) REGULATIONS, 2011 (S.I. No 477 of 2011)

DEROGATION

Granted under Regulation 54 of the European Communities (Birds and Natural Habitats) Regulations 2011, hereinafter referred to as "the Habitats Regulations".

The Minister for Housing, Local Government & Heritage, in exercise of the powers conferred on him by Regulation 54 of the Habitats Regulations hereby grants to **Sean Devaney** of **Galway National Roads Project Office, City Hall, College Road, Galway, County Galway, H91 X4K8** a derogation. It is stated that this derogation is issued:

- A. In the interests of public health and public safety, or for other imperative reasons of overriding public interest, including those of a social or economic nature and beneficial consequences of primary importance for the environment
- B. As there is no satisfactory alternative, and the action authorised by this derogation will not be detrimental to the maintenance of the population of <u>bats</u> referred to below at a favourable conservation status in their natural range.

This derogation authorises the following:

- 1. Roost disturbance
- 2. Actions authorised within the derogation

The derogation is issued in respect of the following **bat species**:

•	Lesser Horseshoe Bat	Rhinolophus Hipposideros
•	Brown Long-Eared Bat	Plecotus Auritus
•	Natterer's Bat	Myotis Nattereri
•	Common Pipistrelle	Pipistrellus Pipistrellus
•	Soprano Pipistrelle	Pipistrellus Pygmaeus
•	Leisler's Bat	Nycatalus Leisler
•	Daubenton's Bat	Myotis Daubentonii
•	Whiskered Bat	Myotis Mystacinus



Terms and Conditions

- 1. This derogation is granted solely to allow the activities specified in connection with the works specified under Section 2 of the accompanying report for **Sean Devaney.**
- 2. All activities authorised by this derogation, and all equipment used in connection herewith, shall be carried out, constructed and maintained (as the case may be) so as to avoid unnecessary injury or distress to any species of **BAT**. Anything done other than in accordance with the terms of this derogation may constitute an offence
- 3. This derogation may be modified or revoked, for stated reasons, at any time.
- 4. The mitigation measures outlined in the application report (**N6 Galway City Ring Road**), together with any changes or clarification agreed in correspondence between NPWS and the agent or applicant, are to be carried out. Strict adherence must be paid to all the proposed measures in the application.
- The actions which this derogation authorise shall be completed between 29th August
 31st December 2025, inclusive
- 6. The works will be supervised by bat ecologist: **Colm Clarke.**
- 7. Further survey work should be carried out in the run up to works commencing in 2028, resulting potentially in modified proposals for mitigation/compensation
- 8. If this derogation addresses works that are subject of a planning application, no such works permitted under this derogation can occur until planning permission is granted.
- 9. If this derogation expires prior to works permitted under this derogation commencing, a new application must be sought in advance, including the provision of any updated data or reports.
- 10. This derogation shall be produced for inspection on a request being made on that behalf by a member of An Garda Síochána or an authorised NPWS officer appointed under Regulation 4 of the Habitats Regulations.
- 11. The local **NPWS Regional Manager**, rebecca.teesdale@npws.gov.ie, must be contacted prior to the commencement of any activity, and if bats are detected on site during the course of the work, under the terms of this derogation.
- 12. On completion of the actions which this derogation authorises, all recordings of bat species affected will be made using the standardised data form provided below and must be submitted to the NPWS within four weeks of the expiry date of this derogation. Included with the below returns form, a report will also be submitted to wildlife.reports@npws.gov.ie detailing results of works and success of mitigation. Both documents must be submitted to constitute a derogation return.

The application form and associated documentation provided by the applicant has been reviewed in full. The application relies on regulation 54(2)(c) 'in the interests of public health and public safety, or for other imperative reasons of overriding public interest, including those of a social or economic nature and beneficial consequences of primary importance for the environment' as the reason chosen for a derogation that they believe applies to the proposed activity.

In the detail provided it is clear that the applicants are relying on the imperative reasons of overriding public interest aspect of Reason C

The applicant has provided reasoning to support test 1 in section 3 of the accompanying report. The applicant has discussed in section 3.2 of the report "Galway City and its environs have critical transport issues that require urgent resolution. To address these transport issues, Galway County Council, Galway City Council, Transport Infrastructure Ireland and the National Transport Authority are collaborating in developing a transport vision for Galway where all elements of transport are working together to achieve an integrated sustainable transport solution. The proposed N6 GCRR which is the subject of this derogation licence, forms an essential part of this transport solution.

The total breakdown of the existing transport network in Galway occurs on a frequent basis as there is no resilience in the network e.g. wet afternoon, road maintenance, vehicle collision and/or signal outage. This random unpredictable shutdown of Galway's transport network costs millions and has the real potential to prohibit Galway functioning as a city or economic engine for the Western Region. The transport issues facing Galway City and its environs as a result of the inadequacy of the existing road network are wide ranging with associated consequential impacts''

The applicants have provided evidence as to the nature and scale of the overriding public interest reasoning and the proposed activity is necessary to achieve these overall objectives. Based on the above this application has passed Test 1 and can now proceed to Test 2.

The application form and associated documentation provided by the applicant has been reviewed in full. Sections 3 and 4 of the Bat Derogation Licence Application Report outlines the development of the Galway Transport Strategy and the development of the N6 Galway City Ring Road, the constraints and fully explores the absence of satisfactory alternatives. The design team for the proposed N6 GCRR, carefully considered and analysed the traffic issues in Galway with the aim of finding a transport solution to create a safer, smarter and sustainable transport system for Galway City and its environs taking into account travel demands, existing infrastructure and environmental constraints. Extensive analysis was undertaken, with full details of this analysis included in Chapter 6 of the N6 Galway City Ring Road (GCCR) 2018 EIAR. Following on from the initial feasibility studies, taking cognisance of the judgement on the 2006 Galway City Outer Bypass scheme and the key constraints of the Lough Corrib Special Area of Conservation (SAC) the several options and scenarios were considered.

At the constraints and option selection stage of the project, a greater proportion of the bat survey effort was focused on describing the Lesser Horseshoe Bat population, given its status as a qualifying interest species of the Lough Corrib Special Area of Conservation (SAC). The presence of other bat species at the constraints and option selection phase had been established by a series of walked and vehicle-based acoustic surveys, surveys of a selection of properties and use of automated detectors to record bat activity across the site. A full assessment of the route options including public consultation was undertaken.

In reviewing the viable route options in each section, an assessment was undertaken under various criteria which sought to balance the potential impact on the ecological constraints, human beings and other constraints. In terms of impacts on bats all of these route options have the potential to adversely affect local population of bats. Further, once chosen, the design of the emerging preferred route option has been refined in as much as possible to eliminate and reduce impacts on the receiving environment.

The applicant has provided satisfactory evidence that there is an absence of any satisfactory alternatives.

I am satisfied that the development will not impact on the conservation status of the listed
species.
It should be noted however, that my assessment is based on the currently provided bat
information and the prospect of works commencing in the coming months. This is clearly not the
case, as the request is for a licence starting in 2028.
While the applicants have completed extensive bat surveys to date, it is likely that some changes in bat numbers and locations will occur between now and 2028. As a result, further survey work
would be needed in the run up to works commencing in 2028, resulting potentially in modified
proposals for mitigation/compensation, before a derogation licence could issue covering the
proposed works period.

If the answer above is Yes then the derogation may be granted, providing Tests 1 and 2 have also been met.
