

## **Derogation Number DER-BAT-2025-318**

# EUROPEAN COMMUNITIES (BIRDS AND NATURAL HABITATS) REGULATIONS, 2011 (S.I. No 477 of 2011)

#### **DEROGATION**

Granted under Regulation 54 of the European Communities (Birds and Natural Habitats) Regulations 2011, hereinafter referred to as "the Habitats Regulations".

The Minister for Housing, Local Government & Heritage, in exercise of the powers conferred on him by Regulation 54 of the Habitats Regulations hereby grants to **Eadaoin Healy** of **Blackwood Associates Architects, 9 Mount Street Crescent, Dublin 2** a derogation. It is stated that this derogation is issued:

- A. In the interests of public health and public safety, or for other imperative reasons of overriding public interest, including those of a social or economic nature and beneficial consequences of primary importance for the environment
- B. As there is no satisfactory alternative, and the action authorised by this derogation will not be detrimental to the maintenance of the population of <u>bats</u> referred to below at a favourable conservation status in their natural range.

This derogation authorises the following:

- 1. Roost disturbance
- 2. Actions authorised within the derogation

The derogation is issued in respect of the following **bat species**:

Brown Long-Eared Bat Plecotus Auritus
 Natterer's Bat Myotis Nattereri



#### **Terms and Conditions**

- This derogation is granted solely to allow the activities specified in connection with the works located at Kilpatrick Church, Kilpatrick, Mullingar, County Westmeath for Eadaoin Healy
- 2. All activities authorised by this derogation, and all equipment used in connection herewith, shall be carried out, constructed and maintained (as the case may be) so as to avoid unnecessary injury or distress to any species of **BAT**. Anything done other than in accordance with the terms of this derogation may constitute an offence
- 3. This derogation may be modified or revoked, for stated reasons, at any time.
- 4. The mitigation measures outlined in the application report (Report in Support of an Application For Derogation Licence Under Regulation 54 & 54A Of The European Communities (Birds And Natural Habitats) Regulations 2011, As Amended With Regard To Bats Occurring At Kilpatrick Church July 2025), together with any changes or clarification agreed in correspondence between NPWS and the agent or applicant, are to be carried out. Strict adherence must be paid to all the proposed measures in the application.
- The actions which this derogation authorise shall be completed between 26<sup>th</sup>
   September 30<sup>th</sup> November 2025, inclusive.
- 6. The works will be supervised by bat ecologist: Patrick Moran.
- 7. No works should take place during the hibernation period (December February inclusive.)
- 8. An endoscope survey should be conducted in advance of works taking place. This survey needs to be carried out by a bat expert. Any crevices where bats are recorded must be preserved and no works should take place that impact on them
- 9. If this derogation addresses works that are subject of a planning application, no such works permitted under this derogation can occur until planning permission is granted.
- 10. If this derogation expires prior to works permitted under this derogation commencing, a new application must be sought in advance, including the provision of any updated data or reports.
- 11. This derogation shall be produced for inspection on a request being made on that behalf by a member of An Garda Síochána or an authorised NPWS officer appointed under Regulation 4 of the Habitats Regulations.
- 12. The local **NPWS Conservation Ranger Triona Finnen**, <a href="mailto:triona.finnen@npws.gov.ie">triona.finnen@npws.gov.ie</a>, must be contacted prior to the commencement of any activity, and if bats are detected on site during the course of the work, under the terms of this derogation.
- 13. On completion of the actions which this derogation authorises, all recordings of bat species affected will be made using the standardised Returns form and must be submitted to the NPWS within four weeks of the expiry date of this derogation. Included with the Returns form, a report will also be submitted to <a href="wildlife.reports@npws.gov.ie">wildlife.reports@npws.gov.ie</a> detailing results of works and success of mitigation. Both documents must be submitted to constitute a derogation return.

## Please outline your analysis below and state how the applicant has provided evidence to support your conclusion:

The application form and associated documentation provided by the applicant has been reviewed in full. The application relies on regulation 54(2)(c) 'in the interests of public health and public safety, or for other imperative reasons of overriding public interest, including those of a social or economic nature and beneficial consequences of primary importance for the environment' as the reason chosen for a derogation that they believe applies to the proposed activity.

In the detail provided, the applicants are relying on the public health and public safety aspect of Reason C and that as outlined in the supporting report, a conservation plan is currently being implemented for Kilpatrick Church. It is further noted that the Kilpatrick Church conservation plan requires urgent works to preserve the structure and that emphasis during the works will be primarily on stabilising the existing building. If the proposed works do not commence, then Kilpatrick Church will fall into further disrepair and is in danger of collapse. The application therefore falls under the public health and public safety aspect of Reason C.

The applicants have provided evidence as to the nature and scale of the public health and public safety reasoning and the proposed activity is necessary to achieve the overall objective. Based on the above this application has passed Test 1 and can now proceed to Test 2

The documentation submitted by the applicant has been reviewed, including the evidence for alternative solutions, these are outlined in an ecological report dated July 2025, submitted as part of the application with regard to bats occurring at Kilpatrick Church.

The purpose of the derogation is to allow the following activity to take place:

The objective of the works is the conservation of a historic structure. The conservation works are vital to the preservation of the historic structure present at Kilpatrick Church. Emphasis during conservation works will be primarily on stabilising the existing fabric, retaining all masonry elements, as far as possible, in their current location. Rebuilding will only to be considered if deemed essential to stabilise the overall structure or where the original fabric and a record of the original construction are present, and if executed, to be based on interpretation of existing evidence. All interventions will be recorded.

The specific situation that needs to be addressed is repair and restoration works are required at Kilpatrick Church in order to prevent the further deterioration of the structure, an investigation of the structure will be conducted and repairs undertaken where the structure is in danger of collapse.

The alternative solutions suggested by the applicant are:

According to the applicant, the only realistic solution is the "Do Nothing Scenario". If the do nothing scenario is implemented, the structure at Kilpatrick will deteriorate further, and this historic structure will be lost. This will not resolve the issue as the structure will eventually collapse destroying any bat roosts present and posing a danger to any roosting bats. Therefore, the 'do nothing scenario' is not considered viable.

The applicant has provided satisfactory evidence that alternative solutions have clearly been considered. As outlined on page 5 of the accompanying report the "do-nothing alternative" was examined by the applicant and this was considered not a viable option. – regional agree with this assessment

Based on the assessment of the application documentation, it is regarded that the applicant has considered all available alternative solutions and at this time no other alternative solutions are apparent.

Having weighed the possible solutions to solve the applicants' problem against the effects of a derogation on the species concerned, it is concluded that the application has passed Test 2 and can proceed to Test 3

This ruin contains a hibernation roost of 5-10 natterer's bats and a number of individual brown longeared bats.

Natterer's bats are relatively rare in Ireland and their hibernation roosts are seldom recorded. Hence this roost is of conservation significance.

It is important that the proposed works are carried out sensitively with the protection of these bats in mind.

Mitigation measures are proposed and providing these are implemented there should be no significant impact on the conservation status of the bats on site

If the answer above is Yes then the derogation may be granted, providing Tests 1 and 2 have also been met.
