

Derogation Number DER-BAT-2025-321

EUROPEAN COMMUNITIES (BIRDS AND NATURAL HABITATS) REGULATIONS, 2011 (S.I. No 477 of 2011)

DEROGATION

Granted under Regulation 54 of the European Communities (Birds and Natural Habitats) Regulations 2011, hereinafter referred to as "the Habitats Regulations".

The Minister for Housing, Local Government & Heritage, in exercise of the powers conferred on him by Regulation 54 of the Habitats Regulations hereby grants to **Melaine McQuade** of **Westmeath County Council, Aras an Chontae, Mount Street, Mullingar, County Westmeath, N91 FH4N** a derogation. It is stated that this derogation is issued:

- A. In the interests of public health and public safety, or for other imperative reasons of overriding public interest, including those of a social or economic nature and beneficial consequences of primary importance for the environment
- B. As there is no satisfactory alternative, and the action authorised by this derogation will not be detrimental to the maintenance of the population of <u>bats</u> referred to below at a favourable conservation status in their natural range.

This derogation authorises the following:

- 1. Roost disturbance
- 2. Actions authorised within the derogation

The derogation is issued in respect of the following **bat species**:

Brown Long-Eared Bat Plecotus Auritus
 Daubenton's Bat Myotis Daubentonii



Terms and Conditions

- This derogation is granted solely to allow the activities specified in connection with the works located at Castlelost Medieval Church Site, Castlelost, Rochfortbridg, County Westmeath for Melaine McQuade
- 2. All activities authorised by this derogation, and all equipment used in connection herewith, shall be carried out, constructed and maintained (as the case may be) so as to avoid unnecessary injury or distress to any species of **BAT**. Anything done other than in accordance with the terms of this derogation may constitute an offence
- 3. This derogation may be modified or revoked, for stated reasons, at any time.
- 4. The mitigation measures outlined in the application report (**Derogation Application** for repairs to Castlelost Church, Co Westmeath), together with any changes or clarification agreed in correspondence between NPWS and the agent or applicant, are to be carried out. Strict adherence must be paid to all the proposed measures in the application.
- 5. The actions which this derogation authorise shall be completed between 3rd October 31st December 2025, inclusive.
- The works will be supervised by bat ecologist(s): Brian Keeley, Donna Mullen & Ferdia Keeley
- 7. If this derogation addresses works that are subject of a planning application, no such works permitted under this derogation can occur until planning permission is granted.
- 8. If this derogation expires prior to works permitted under this derogation commencing, a new application must be sought in advance, including the provision of any updated data or reports.
- 9. This derogation shall be produced for inspection on a request being made on that behalf by a member of An Garda Síochána or an authorised NPWS officer appointed under Regulation 4 of the Habitats Regulations.
- 10. The local NPWS Conservation Ranger Damian Murtagh, damian.murtagh@npws.gov.ie, must be contacted prior to the commencement of any activity, and if bats are detected on site during the course of the work, under the terms of this derogation.
- 11. On completion of the actions which this derogation authorises, all recordings of bat species affected will be made using the standardised Returns form and must be submitted to the NPWS within four weeks of the expiry date of this derogation. Included with the Returns form, a report will also be submitted to wildlife.reports@npws.gov.ie detailing results of works and success of mitigation. Both documents must be submitted to constitute a derogation return.

The application form and associated documentation provided by the applicant has been reviewed in full. The application relies on regulation 54(2)(c) 'in the interests of public health and public safety, or for other imperative reasons of overriding public interest, including those of a social or economic nature and beneficial consequences of primary importance for the environment' as the reason chosen for a derogation that they believe applies to the proposed activity.

In the detail provided, it is clear that the applicants are relying on the health and safety aspect of Reason C for the proposed works. As outlined on page 4 of the accompanying report, Castlelost Church, Co. Westmeath is a historical building under the ownership of Westmeath Co. Council, the proposed works are urgent in nature, and the Derogation is sought to prevent further collapse to sections of the structure.

The proposed works will also remove loose and fallen masonry to rebuild and retain sections of this historical building, which currently pose a health and safety risk to the general public and contractors. The application therefore falls under the public health and public safety aspect of Reason C.

The applicants have provided evidence as to the nature and scale of the public health and public safety reasoning and the proposed activity is necessary to achieve the overall objective. Based on the above this application has passed Test 1 and can now proceed to Test 2

All documents provided (Bat Derogation Licence Application and Supporting Information) regarding the application for a Regulation 54 derogation to complete works at Castlelost Church, Tyrrellspass, County Westmeath have been reviewed in full.

The applicant states within this documentation that a do noting approach (alternative solutions considered) to the works proposed at Castlelost Church will have a detrimental effect on the future general condition of the building (with negative effect on natural and cultural heritage and safety of the structure to the public).

In the documentation associated with the application, it is noted that Castlelost Church is a roost to two bat species – Daubenton's Bat *Myotis daubentoni* and Brown Long Eared Bat *Plecotus auritus*. The associated documentation also mentions that the site is a feeding and commuting site of six other bat species.

Regional agree the repairs suggested to the ruin will preserve bat roosts noted in associated documentation. In addition to the preservation of roosts, proposed on site repair works will generate other possible roost opportunities by the retention of crevices in areas under repair.

It is also noted in documentation that works will not be carried out during the period of peak bat activity. Work proposed in the associated documentation will be carried out between September and December 2025. Specific vegetation management has also been suggested in associated documentation to make the site more suitable for bat species to feed and rest.

The site is also important for bird species. One species was noted in the documentation associated with this application as nesting in Castlelost Church ruin in 2025 - a Swallow *Hirundo rustica*, an amber listed bird of conservation concern in Ireland. It is noted and mentioned in associated documentation that timing of works will give due consideration to the breeding activities of this species at Castlelost Church.

The bat and bird species encountered on site and mentioned in the documentation associated with this application are comprehensively considered in the proposed works. Any repair will enhance the site for the abovementioned species, will benefit the condition of the site, will be carried out in a period of low species activity at the site and will be supervised by an ecologist to prevent any adverse effect on species present. In the process of repair to the building, species using the site are considered and the cultural heritage and safety status of the site preserved.

The information presented by the applicant suggests that they have met the conditions of test 2

The church ruin provides a roost to individuals of two bat species – Daubenton's Bat *Myotis* daubentoni and Brown Long Eared Bat *Plecotus auritus*. Both species are in favourable conservation status and mitigation measures are proposed to retain the value of the ruin for bats going forward. I am satisfied that there should be no significant impact on the conservation status of the bats on site.
