**GUIDELINES FOR AN APPLICATION FOR A 12 MONTH LICENCE TO POSSESS  
AN INJURED OR DISABLED PROTECTED WILD BIRD/ANIMALS**

**Part 1.**

**Personal Details:**

All sections to be filled in or form could be returned to applicant. If you are completing the application form on behalf of an organisation – please ensure that the organisation’s details are all correct. The person filling in the form should include their role within the organisation.

**Part 2.**

**Name of Head of Organisation:**

If you are completing the application form on behalf of an organisation – please ensure that the head of the organisation is listed in the section provided.

**Charity Details**

If your organisation is a registered charity – please provide the registered charity number

**How is Your Organisation Structured: E.g. Board/Directors/Individuals?**

Please provide a breakdown of how your organisation is structured. Do you have board of directors, chairperson, committee or individuals within the group? Provide the structure in the space provide or alternatively – provide further details with this application.

**How long has the Organisation/Individual being in operation:**

Please provide either the date of formation or the number of years in operation.

**Do you hold a Zoo Licence?**

If you do hold a Zoo Licence – please provide details of the licence issued to you.
