Other Site Characteristics

This is a steep-sided turlough basin surrounded by fairly intensive farmland. It is bordered in part by a rock outcrop and small cliff and contains a long-lasting natural pond which is used by cattle. The steepness of the slopes compresses the normal vegetation zonation into noticeable bands.

4.2 Quality and importance

The site is in good condition with a high level of vegetation diversity for its small size. It is an unusual turlough because of its great range of water levels and for the exposure of limestone cliff at its edge. It is probably unique in Mayo.
