### Other Site Characteristics

A sessile oak wood, developed on soils derived from schists and gneiss, on gently undulating terrain. The site is bounded on the eastern margin by the Owenee River.

### 4.2 Quality and importance

A sessile oak wood of the Blechno-Quercetum petraea scapanietosum, a rare hypo-oceanic community of

restricted distribution. It is one of the few remaining fragments of woodland in the region. Considerable past disturbance has fragmented the wood, which nevertheless retains a typical structure and flora in places and contains the Red Data species *Cephalanthera longifolia*.
