Other Site Characteristics

Situated on a slope on the eastern side of the Ballysadare River, the acidic soils are underlain by gneiss. In places the woodland has a fairly natural open character and a typical flora. There is a rich epiphytic flora. There is, however, much inter- and under-planting with commercial conifers. Habitat diversity is created by an area of heath, which is dominated by *Calluna vulgaris*, at Union Rock.

4.2 Quality and importance

A typical western oakwood of the *Blechno-Quercetum* type, but ecological interest lowered by the presence of conifers and other exotics. Also, regeneration may be low. Nevertheless, one of the best remaining oakwoods in the region and has good prospects as it is state owned.
