Other Site Characteristics

This site consists of a large two-storey derelict dwelling situated near Quin village, County Clare. It is used by >100 Lesser Horseshoe Bats as a summer breeding site. The bats roost in the roof space. The surrounding mature trees and hedgerows are suitable foraging habitats for the bats.

4.2 Quality and importance

As >100 Lesser Horseshoe Bats (*Rhinolophus hipposideros*) use this site as a summer breeding site, it is a site of international importance. It is also important because it is situated along the eastern limit of the species' distribution in Ireland.
