#### Other Site Characteristics

Carrigeenamronety Hill is an eastern, lower outlier of the Ballyhoura Mountains which straddles the border of Counties Cork and Limerick. It is underlain by old red sandstone and silurian rocks and its summit is crowned by an imposing escarpment of silurian conglomerate rock. Heath forms the dominant vegetation of the site, especially in the higher sections. Areas of unimproved Molinia grassland and improved grassland are found at lower altitudes. Commercial forestry occurs commonly on the hill, outside the site, and on other high ground to the west.

#### 4.2 Quality and importance

The importance of this site lies in the presence of *Trichomanes speciosum*. Thirteen plants were recorded from the site in 1976. These were growing in clefts in rock.
