### Other Site Characteristics

Site is situated in the foothills of the Slieve Aughty Mountains, almost 3 km east of Lough Cutra. Area drains into the Owendalulleagh River. Over 60% of the site is wooded, the remainder being mainly heath habitat with colonising *Betula* and *Quercus* trees. Small areas of wet grassland and marsh vegetation also present, along with a stream and small lake. Woodland has been managed in past. Light grazing occurs. Surrounding areas are used for afforestation and rough grazing.

### 4.2 Quality and importance

This oak woodland is classified as *Blechno-Quercetum petraeae* var. *coryletosum*. While of only moderate size, it a good example of the type and generally of good quality. Typical structure Regeneration is good and is occurring in previously cut areas. Has the rare and Red Data Book species *Cephalanthera longifolia*. Both *Martes martes* and *Meles meles* occur. Similar woods of this quality are scarce in this part of country.
