Other Site Characteristics

The site consists of a disused stone cottage situated approximately 5 km north-west of Tulla in Co. Clare. The site is surrounded by agricultural land.

4.2 Quality and importance

This site supports an internationally important summer roost of *Rhinolophus hipposideros*. The cottage is in good condition and provides stable and undisturbed summer roosting conditions for the bats. It is one of a number of maternity roosts known from within a 5km radius and is located in an area with a large population of lesser horseshoe bats. Foraging areas and winter hibernation sites have not yet been established although it may be linked to a known hibernaculum situated approximately 3km away (Newgrove House).
