National Peatlands Strategy Mid-Term Review and Implementation Plan

Background

The National Peatlands Strategy 2015-2025 has as its vision statement "to provide a long-term framework within which all of the peatlands within the State can be managed responsibly in order to optimise their social, environmental and economic contribution to the well-being of this and future generations". It sets out a cross-governmental approach to managing issues that relate to peatlands, including: compliance with relevant national and international environmental legislation, agreements, plans and policies; climate change; forestry; water quality; flood control; energy; nature conservation and restoration; land use planning; and agriculture. The Strategy has been developed in partnership between relevant Government Departments/State bodies and key stakeholders through the Peatlands Council.

It is underlined by 25 key principles and commits to the undertaking of 32 actions across various sectors and themes, including, *inter alia*, Research, Tourism, Agriculture, Forestry, Conservation, Restoration, Peat Extraction, Energy, Water Quality and Climate Change.

Progress reports on the Strategy have been published for 2017 and for 2018/2019, and this review has been carried out in the context of those reports.

Introductory context

The original principles and actions of the Strategy were a positive attempt to stake out a plan in a rapidly changing context, with the understanding that circumstances were evolving and that goals and actions would need to be updated to match them: it was always intended as a living document. Hence the mechanism of the mid-term review.

The purpose of this mid-term review is, therefore, not to reiterate the progress reports but to provide a broader assessment on where the Strategy currently is, what it can achieve over the next three years, and, if necessary, to propose changes to the actions set out in the Strategy to refocus it in line with its overall goals and the current context.

A significant achievement of the Strategy is the coordinated focus and attention it has brought to bear on peatlands issues and the concomitant cooperation between Government Departments, State agencies and State bodies it has enabled.

For each action under the Strategy, a lead body is designated for its implementation, with other bodies also being indicated in most cases. A number of major projects and initiatives have begun or been continued as part of the implementation of the actions of the Strategy, which suggests the explicit setting of concrete goals and working to fulfil them has been an effective approach. However, progress in the implementation of some actions has been slow.

What has changed since publication of the Strategy?

A number of other significant policies, programmes and plans of relevance have come into existence since the National Peatlands Strategy was published in 2015, including:

While these have not taken over the functions of the National Peatlands Strategy, it is necessary that the future direction of the Strategy should take the goals of these other plans and policies into consideration, especially where there may be overlap with desired outcomes or actions of the Strategy.

More broadly, the conversations around peatland use, environmental and biodiversity goals, climate action, and the commercial use of peat have all changed significantly over the past seven years and the prevailing principles and actions in the Strategy have been reviewed in that context.

As part of the plan for a more sustainable island, the National Development Plan states that there is a need for coordinated investment to conserve cross-border region peatlands to support biodiversity, provide valuable ecosystem services and act as carbon sinks. It is also noted that an action in the Programme for Government is to 'explore how bodies established under the Good Friday Agreement can ensure that there is a joined-up approach to environmental issues on an all-island basis and seek to develop an all-island strategy to tackle climate breakdown and the biodiversity crisis'. The actions set out is this interim review supports these aims.

Additionally, on a positive note, a number of the specific actions set out in the Strategy have been completed. Therefore, in this mid-term review, an assessment has been made of which actions could be closed, which actions need only be monitored, and which actions require a combination of both.

What can be achieved in the next 4 years (2022 to 2025) of the National Peatlands Strategy?

In the second half of the Strategy's ten-year duration, the focus must shift to accomplishing as much as possible in service of the Strategy's Principles. As much measurable progress as possible needs to be made in the implementation of the Strategy. Any new areas that may come into prominence could be considered in a successor Strategy.

With that in mind the actions set out in the National Peatlands Strategy have been updated into a new Implementation Plan, which focuses on refining outstanding actions and prioritising measurable, achievable objectives.

This revision of the Strategy will increase the effectiveness of the Strategy in achieving its ultimate goals, improve coordination and communication between relevant Government Departments, State agencies and State bodies, and set out the actions that are being prioritised and will be undertaken over the next four years. The Implementation Plan is intended as a pragmatic and practical approach to focus on what is achievable, what should be prioritised, and what can be measured and reported on effectively, through the National Peatlands Strategy progress reports.

Certain actions set out in the National Peatlands Strategy have been achieved at this point or have progressed to a stage where they require monitoring of implementation. These actions will continue to

be monitored by the Peatlands Strategy Implementation Group (comprised of representatives of the relevant Government Departments and State bodies) as appropriate.

Public Consultation

A National Peatlands Strategy mid-term review document was subject to a two month public consultation period ending on 30 June 2021. Forty-three submissions were received during the consultation and are available at <u>http://www.npws.ie</u>. The submissions were from a wide variety of stakeholders in the peatlands sector, including individuals, community groups, professional associations, groups representing young people, farmers, NGOs, and local authorities. A majority of individual submissions were from the midlands region.

The vast majority of submissions welcomed the mid-term review in general, and considered it a positive move in the development of the National Peatlands Strategy. An interest in, and concern for, climate change and biodiversity was evident throughout the submissions received, with many noting the changes in official policy in this area since 2015 and the Government's acknowledgement of a Climate Emergency in 2019. The value of peatlands for carbon sequestration was also repeatedly stressed. Throughout a number of submissions there were concerns regarding the prevalence of turfcutting contrary to national and EU law. There were also concerns expressed regarding the impact of planning legislation in relation to the production of peat for use in horticulture, as well as perceived gaps in planning legislation allowing harvesting on smaller sites. A number of groups asked for a mechanism to be introduced to suggest sites for designation. Bord na Móna's announcement of an end to peat extraction on its properties was a feature in a number of submissions, which also focused on what is perceived to be the lack of a landscape-level planning approach for peatlands in Ireland. Concerns around employment, economics, tourism, and turf cutting traditions were prevalent in the submissions, with a number of submissions noting the importance of traditional turbary rights, as well as loss of access to fuel/energy supplies and loss of land value that can occur for farmers and turf cutters when sites are protected.

The submissions received have been taken into account in the finalisation of the National Peatlands Strategy mid-term review and Implementation Plan.

Climate Action Plan 2021 and Annex of Actions

The Climate Action Plan 2021 provides a detailed plan for taking decisive action to achieve a 51% reduction in overall greenhouse gas emissions by 2030 and sets Ireland on a path to reach net-zero emissions by no later than 2050, as committed to in the Programme for Government and set out in the Climate Act Plan 2021. An Annex of Actions, including actions relating to peatlands, supports the delivery of the Climate Action Plan 2021. Given the significant role of peatlands in climate action, and, to give a complete overview of all national peatlands actions in this document, peatland actions from the Climate Action Plan Annex of Actions have been included in this National Peatlands Strategy Implementation Plan 2022-2025. It is noted that the Climate Action Plan 2023 is currently under preparation. The publication of this Plan will be welcomed as another important document regarding the evolution of peatlands management in Ireland.

Note on the table Implementation of Prioritised Actions 2022-2025 set out below.

Actions A – P relate to actions set out in the National Peatlands Strategy, however, these actions have been refined to take into account developing national policies and programmes related to peatlands. Actions Q - GG in the table below are peatland actions which are set out in the Climate Action Plan 2021, Annex of Actions.
